## MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING TUESDAY, OCTOBER 13, 2020

Held in the auditorium of the York Township Offices, 1502 South Meyers Road, Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Steve Militello, of 18W470 Edward Street, Lombard, led the Pledge of Allegiance.

Trustee Morrissey motioned to approve the minutes of the September 8, 2020 Regular Board Meeting, seconded by Trustee Rupp Srch. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey and Supervisor Valle voted "Aye." Motion passed.

Public Comment: None.

Trustee Morrissey moved that the bills in the amount of \$921,536.17, having been duly audited, be approved for payment and charged to the proper accounts, seconded by Trustee Rupp Srch. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey and Supervisor Valle voted "Aye." Motion passed.

Supervisor Valle announced that quotes were received from three companies for the demolition of the Yorkfield Civic Center Building, the highest being \$123,500. Trustee Rupp Srch made a motion to accept the proposal of Alpine Demolition Services in the amount of \$33,920, seconded by Trustee Cuzzone. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey and Supervisor Valle voted "Aye". Motion passed.

Supervisor Valle reported that Angela Tanner had the idea to put up an awning so that people waiting in line to get food from the Food Pantry would be protected from the elements. She submitted an application to the Northern Illinois Food Bank and received a check for \$18,000 to pay for the awning. The Township will use the rest of the monies for heaters. Trustee Rupp Srch made a motion to accept the proposal of ASL Metal Fabricators, Inc. in the amount of \$14,480 for the awning, seconded by Trustee Cuzzone. Morrissey. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey and Supervisor Valle voted "Aye". Motion passed.

## There was no closed session.

Under new business, Supervisor Valle mentioned that Trustee Rupp Srch attended the meeting of the Metropolitan Townships Association. Supervisor Valle asked for volunteers to pass out turkeys at the York Township Food Pantry on November 18, 2020 from 1:30 PM to 3:30 PM. Trustee Rupp Srch advised that Tri Town YMCA is having a drive-thru German dinner pickup on October 15, 2020 for \$15.00 and the proceeds will be used to support the programs at Tri Town YMCA. Trustee Cuzzone advised that the Turkey Trot is going virtual this year, sign-up is at dangibbonsturkeytrot.org and participants will download an app and can participate virtually anytime during a one week period and you can run/walk anywhere. Trustee Cuzzone advised that pursuant to an intergovernmental agreement between York Township and the City of Elmhurst, this Thursday the City of Elmhurst is delivering eight slightly used computers for our seniors. Under old business, Trustee Morrissey inquired about the Township's transportation services, General Assistance and meals served to seniors. Supervisor Valle answered that the Transportation Department is still providing rides, especially for medical appointments, that General Assistance requests have almost doubled and that the Township through 16 volunteers is providing frozen meals to seniors.

There being no further business, Trustee Cuzzone moved to adjourn the meeting to the Regular Board Meeting to be held on Tuesday, November 10, 2020 commencing at 7:30 p.m., seconded by Trustee Rupp Srch. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
