## MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING TUESDAY, NOVEMBER 10, 2020

Held in the auditorium of the York Township Offices, 1502 South Meyers Road, Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Erica Militello led the Pledge of Allegiance.

Trustee Morrissey motioned to approve the minutes of the October 13, 2020 Regular Board Meeting, seconded by Trustee Rupp Srch. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Public Comment: None.

Trustee Morrissey moved that the bills in the amount of \$943,927.59, having been duly audited, be approved for payment and charged to the proper accounts, seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Supervisor Valle read the Township Levy Ordinance YT-11-10-20-TF numbers, noting that numbers have not changed since the workshop:

Trustee Cuzzone moved to approve Tax Levy Ordinance YT-11-10-20-TF, seconded by Trustee Rupp Srch. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Supervisor Valle read the Police District Tax Levy Ordinance YT-11-10-20-PD in the sum of \$142, 971 which has not changed since the workshop. Trustee Rupp Srch moved to approve the Police District Tax Levy Ordinance YT-11-10-20-PD, seconded by Trustee Cuzzone. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Highway Commissioner Schroeder read the numbers for Road and Bridge Levy Ordinance YT-11-10-20-R, noting that the numbers have not changed since the workshop:

Trustee Rupp Srch moved to approve Road and Bridge Levy Ordinance YT-11-10-20R, seconded by Trustee Cuzzone. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Supervisor Valle recommended initiating the process to go out for public bid to try to sell York Road Property located at the NEQ of York Road and Route 88 in DuPage County, Illinois, noting that the Township could accept the highest bid or reject any and all bids. Trustee Rupp Srch moved to authorize the Town Clerk to publish notice seeking public bids to sell the York Road Property, seconded by Trustee Cuzzone. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Trustee Cuzzone read Ordinance YT-11-10-20, an Ordinance Establishing the Compensation for Elected Officials. Trustee Morrissey moved to approve Ordinance YT-11-10-20, seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Supervisor Valle noted that at the Special Town Meeting the electors voted to extend the current lease with the York Center Park District to its maximum allowable length being an additional 15 years expiring in 2050. Trustee Rupp Srch moved to approve Ordinance YT-11-10-20A Extending the Lease Agreement with York Center Park District., seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Trustee Cuzzone moved to accept the proposal in the amount of \$14,550.00 of NES Environmental for pre-demolition abatement of asbestos at the Yorkfield Civic Center on Lexington in Elmhurst, seconded by Trustee Morrissey. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Trustee Mussatto read Resolution YT-11-10-20 Honoring Centenarian Tracie Banser. and moved to approve Resolution YT-11-10-20, seconded by Trustee Morrissey. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Trustee Mussatto read Resolution YT-11-10-20A Honoring Centenarian Lonnie Buseman and moved to approve Resolution YT-11-10-20A, seconded by Trustee Morrissey. On roll call, Trustees Rupp Srch, Cuzzone, Morrissey, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

There was no closed session.

Under new business, Supervisor Valle advised that on November 19, 2020 there is an MTA training class via ZOOM. Supervisor Valle reminisced that the 18<sup>th</sup> Anniversary Edition of *The Elmhurst Independent* included a photograph of the Dan Gibbons Turkey Trot Foundation check of \$3,700.00 to York Township. Trustee Cuzzone reminded the public that the Turkey Trot is virtual this year. Trustee Morrisey observed that today is the 240th anniversary of the founding of the US Marine Corps. Trustee Rupp Srch announced that the Villa Park VFW is dedicating and renaming its banquet hall in honor of Sid Bergh. Town Clerk Kordik announced that the York Township Republican Caucus will be held on December 1, 2020 at the Elmhurst American Legion T.H.B. Post 187 starting at 7:00 p.m., with the doors to open at 6:00 p.m. and that the York Township Democratic Caucus will be held on December 1, 2020 at Cortesi Veterans Memorial Park starting at 7:30 p.m.

Under old business, Trustee Morrissey commended Supervisor Valle, Highway Commissioner Schroeder and Assessor Wilkins for not maximum the amounts of their levies. Town Clerk Kordik shared an historical tid-bit from the March 3, 1860 when "Fence Viewers" resolved a dispute between two adjoining property owners.

Supervisor Valle wished everyone a Happy Thanksgiving. There being no further business, Trustee Cuzzone moved to adjourn the meeting to the Regular Board Meeting to be held on Tuesday, December 8, 2020 commencing at 7:30 p.m., seconded by Trustee Rupp Srch. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
