MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING TUESDAY, JUNE 14, 2022

Held in the auditorium of the York Township Offices, 1502 South Meyers Road, Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Nancy Raimondi led the Pledge of Allegiance.

Supervisor Valle mentioned the recent passing of Jim Ryan, former Illinois Attorney General. A moment of silence was given in remembrance of Jim Ryan.

Trustee Rupp Srch motioned to approve the minutes of the May 10, 2022, Regular Board Meeting, seconded by Trustee Militello. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Trustee Mussatto moved that the bills in the amount of \$1,069,569.15 having been duly audited, be approved for payment and charged to the proper accounts, seconded by Trustee Rupp Srch. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

There was no closed session. Under new business Trustee Rupp Srch reminded everyone that the Villa Park Summer Fest is this coming Saturday, June 18, 2022, from 10:00 am to 10:00 pm.

Under old business, Supervisor Valle mentioned in Elected Officials packets is information from Clarke Mosquito about West Nile virus, the success of the recent blood drive held at the Township, and the celebration of Rita Spearman's 91st birthday. Deputy Town Clerk Schroeder shared an historical tid-bits from 1926. A Notice of Special Election in the Town of York was held on the 6th day of July 1926 at 125 South York Street in the City of Elmhurst. "Public Notice was given by order of the Highway Commissioner for a vote by ballot on the proposition to borrow money and issue bonds to the amount of \$21,000 for the purpose of building a bridge having a span of 150 feet over

Salt Creek on what is known as 31st Street. Said election will be of in from Seven O'clock am to Five O'clock pm daylight savings time. Dated, Town of York, DuPage County, Illinois, June 17, 1926." The notice was posted at 8 locations around the Township on billboards, at grocery stores & at Graue Mill. The "Canvasing Board of the Town of York certified results were 31 votes for and 1 against." The board consisted of Edwin F Deicke, Supervisor, Ernest Stuenkel, Assessor and Henry Specht, Town Clerk.

There being no further business, Trustee Rupp Srch moved to adjourn the meeting to the Regular Board Meeting to be held on Tuesday, July 12, 2022, commencing at 7:30 p.m., seconded by Trustee Militello. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
