## MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING WEDNESDAY, NOVEMBER 9, 2022

Held in the auditorium of the York Township Offices, 1502 South Meyers Road, Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Nancy Raimondi led the Pledge of Allegiance.

Trustee Rupp Srch motioned to approve the minutes of the October 11, 2022 Regular Board Meeting, seconded by Trustee Militello. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Public Comment: None

Trustee Mussatto moved that the bills in the amount of \$360,819.71, having been duly audited, be approved for payment and charged to the proper accounts, seconded by Trustee Pacilli. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Town Fund Levy, Police Levy, Road District Public Hearing & Passage:

Supervisor Valle asked for a Motion to open the Public Hearing. At 7:33 pm Trustee Rupp Srch moved to open the Public Hearing for the Town Fund Levy, Police Levy, and Road District Levy, seconded by Trustee Pacilli. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Supervisor Valle asked for any comments from the Public several times. Hearing none, at 7:35 p.m., Trustee Militello moved to close the Public Hearing, seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Town Fund Levy Ordinance No. YT-11-9-22-TF Passage:

Supervisor Valle read the appropriations for the Tax Levy Township Fund Ordinance No. YT-11-9-22-TF for the 2023-2024 Fiscal Year noting that the numbers are the same as proposed at the workshop:

Trustee Rupp Srch made a motion to approve Town Fund Ordinance No. YT-11-9-22-TF in the total amount of \$3,530,884, seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Police District Levy Ordinance No. YT-11-9-22-PD Passage:

Supervisor Valle read the appropriations for the Police District Tax Levy Ordinance No. YT-11-9-22-PD for the 2023-2024 Fiscal Year in the amount of \$159,169, the same as proposed at the workshop.

Trustee Rupp Srch made a motion to approve the Police District Ordinance No. YT-11-9-22-PD in the amount of \$159,169, seconded by Trustee Militello. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye." Motion passed.

Road District Levy Ordinance No. YT-11-9-22-R Passage:

Supervisor Valle read the appropriations for the Road District Tax Levy Ordinance No. YT-11-9-22-R for the 2023-2024 Fiscal Year:

Supervisor Valle stated the numbers are the same as proposed at the workshop.

Trustee Rupp Srch made a motion to approve the Road District Ordinance No. YT-11-9-22-R in the amount of \$3,452,245, seconded by Trustee Pacilli. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye." Motion passed. Supervisor Valle thanked everyone on the dais and staff for working on the Levy.

There was no closed session. Under new business, Trustee Rupp Srch mentioned upcoming Friday is Veteran's Day and many area VFWs and American Legion organizations will be celebrating with ceremonies at 11:00 am.

Under old business, Supervisor Valle stated in everyone's packet included is a picture of Lombard resident Trudy Petko who turned 95 years old, picture and information from the Pet Food Event on October 15, picture of Elmhurst resident Tom Karo who celebrated his 95<sup>th</sup> Birthday at Town Hall, and picture and information of Lombard resident Mr. Paul Powers who personally donated two carts full of food to the York Township food pantry. Supervisor Valle wished everyone a happy and joyous Thanksgiving and to remember our veterans and those serving overseas. Supervisor Valle also offered belated birthday wishes to Trustee Mussatto (September) and Trustee Pacilli (October). Town Clerk Cuzzone reminded everyone of the Annual Dan Gibbons Turkey Trot taking place in downtown Elmhurst on Thanksgiving morning at 9:00 a.m. All the monies raised from the fun run go towards helping eradicate hunger in DuPage County. Trustee Rupp Srch mentioned the Villa Park VFW will be hosting 45 Recruits from the Naval Base on Thanksgiving Day.

Town Clerk Cuzzone shared an historical tid-bit from a Board meeting on March 24, 1964 at 7pm to audit the bills, and noted the bills were typed into the minutes. The Board met again at 8 pm that same night to read the tentative budget for fiscal year 1964/1965. A separate meeting was held on March 31, 1964 for a Public Hearing for the Road and Bridge tentative budget. These tentative budgets were presented at the Annual Town Meeting on April 7, 1964 for approval.

There being no further business, Trustee Militello moved to adjourn the meeting to the Regular Board Meeting to be held on Tuesday, December 13, 2022 commencing at 7:30 p.m., seconded by Trustee Mussatto. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
