MINUTES

Township Clerk Anthony A. Cuzzone called the Annual Town Meeting to order at 7:00 p.m.

Deacon Tony Spatafore from Visitation Parish gave the Invocation.

Reid Foltyniewicz led the Pledge of Allegiance.

Township Clerk Anthony A. Cuzzone welcomed all to the Annual Town Meeting of York Township for April 11, 2023. He advised that notice of the meeting had been published in the local newspapers, the Township's website, and in the building, that tonight's meeting would follow the agenda approved by the Township Board at its March meeting, and only registered voters in York Township have the right to vote on any issues requiring a vote at this evening's meeting. Clerk Cuzzone stated Annual Town Meetings were being held tonight in every township in the State of Illinois. Cuzzone thanked the volunteers who helped with set up, check-in, and verified the voter registration status of all electors. Those mentioned included Deputy Supervisor Nadia Hajduk, HR/Deputy Clerk Stacy Schroeder, General Assistance Director Pam Sarno, Food Pantry Manager Angela Tanner, Senior Sun Author-Photographer-Accts Payable Amy Kofink, Jeff Mussatto, Ellen Greer, Dan Kordik, Paul Hinds, Reid Foltyniewicz, Legal Counsel Ken Florey and Neal Smith, Deacon Tony Spatafore, Deanna Wilkens, and Supervisor John Valle.

Township Clerk Cuzzone then called for nominations for Moderator of the Annual Town Meeting. Paul Hinds made a motion to nominate Jeff Redick as Moderator of the meeting, seconded by Rae Rupp Srch. Cuzzone called for other nominations several times. Hearing none, Cuzzone recognized Dick Schroeder who made a motion to close nominations and to cast a unanimous ballot for Jeff Redick, seconded by Steve Militello. Motion to close the nominations passed by unanimous voice vote. Town Clerk Cuzzone called for a voice vote for all those in favor to elect Jeff Redick to be Moderator of this Annual Town Meeting. The voice vote was unanimous, and Cuzzone declared that Jeff Redick would be the Moderator for this Annual Town Meeting. Township Clerk Cuzzone then administered the oath of office of Moderator of the Annual Town Meeting to Jeff Redick who signed the oath as Moderator, after which time Mr. Redick presided over the rest of the meeting.

Eric Vincent made a motion to approve the minutes of the Annual Town Meeting of April 12, 2022, seconded by Anthony Pacilli. Motion passed by unanimous voice vote.



Deanna Wilkins gave the Benediction.


