

MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES
REGULAR BOARD MEETING
TUESDAY, OCTOBER 11, 2022

Held in the auditorium of the York Township Offices, 1502 South Meyers Road,
Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Trustee Mussatto led the Pledge of Allegiance.

Trustee Rupp Srch motioned to approve the minutes of the September 13, 2022 Regular Board Meeting, seconded by Trustee Militello. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Public Comment: None

Trustee Mussatto moved that the bills in the amount of \$798,395.25, having been duly audited, be approved for payment, and charged to the proper accounts, seconded by Trustee Pacilli. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Dick Schroeder, Highway Commissioner, read the proposed Road District Levy:

Supervisor Valle stated if anyone has any questions to please call the Assessor, Supervisor, or the Highway Commissioner.

Supervisor Valle presented background information and asked for approval to hire Mary Beth Datavs as a part-time driver for the Senior Transportation at \$12/hr not to exceed 20hrs/week.

Trustee Militello motioned to approve hiring Mary Beth Datavs as a part-time Transportation Driver for no more than 20hrs/week, seconded by Trustee Mussatto. For clarification, Supervisor Valle stated past practice has been to hire at \$10/hr, however, the Governor has decreed each year the wage needs to go up. Therefore, this year the starting minimum wage is \$12/hr. On roll call, Trustees Rupp Srch, Pacilli, Militello, Mussatto, and Supervisor Valle voted "Aye". Motion passed.


There was no closed session. Under new business, Town Clerk Cuzzzone mentioned the Annual Dan Gibbons Turkey Trot held in Elmhurst on Thanksgiving morning at 9:00 am will take place this year in person, and the Honorary Starter will be Jack Island, former owner of the Silverado Restaurant on Spring Rd. in Elmhurst. The monies raised from the Turkey Trot goes toward eradicating hunger in DuPage County.

Under old business, Supervisor Valle reminded everyone of the free Pet Pantry event coming up this weekend, October 15, and asked if anyone would like to volunteer to assist with traffic control since 300 to 400 vehicles are expected. The Supervisor went on to mention in everyone's packet is an announcement that Royce Realty & Management Company on Butterfield Rd in Oakbrook Terrace, donated \$1,250.00 to the York Township Food Pantry, and the Villa Park Lions Club donated \$200.00 to the Food Pantry. Trustee Rupp Srch mentioned Larry, known as Lions Larry and was always very generous with his donations, passed away this past week; wake & funeral is tomorrow Oct 12 at St. A's at 9:30am. Trustee Rupp Srch still looking for volunteers and donations on Thanksgiving for hosting the Naval Recruits. Town Clerk Cuzzzone shared an historical tid-bit from a meeting on the 4th day of April 1850 where the Township Board was approving By-Laws and discussed the control of certain animals at-large. Notices

were distributed and if the animals were not claimed by their owners, the Poundmaster would sell the animals at auction.

There being no further business, Trustee Rupp Srch moved to adjourn the meeting to the Regular Board Meeting to be held on Wednesday, November 9, 2022 commencing at 7:30 p.m., seconded by Trustee Mussatto. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
