MINUTES OF THE YORK TOWNSHIP BOARD OF TRUSTEES REGULAR BOARD MEETING

September 10, 2024

Held in the auditorium of the York Township Offices, 1502 South Meyers Road, Lombard, Illinois.

Supervisor John W. Valle called the meeting to order at 7:30 p.m.

Nancy Raimondi led the Pledge of Allegiance.

Trustee Rupp Srch motioned to approve the minutes of the August 13, 2024 Regular Board Meeting, seconded by Trustee Whipple. On roll call, Trustees Rupp Srch, Pacilli, Whipple, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Public Comment: None

Trustee Mussatto moved that the bills in the amount of \$374,502.77 having been duly audited, be approved for payment and charged to the proper accounts, seconded by Trustee Pacilli. On roll call, Trustees Rupp Srch, Pacilli, Whipple, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

Supervisor Valle reported the part-time driver approved for hire at the previous meeting has found full time employment because he needed insurance, and has apologized profusely. The Supervisor presented the employment application of Rich Kastory for consideration of hiring a part-time driver for the Senior Transportation System to replace the previous applicant, at a starting pay of \$14.00/hr., no insurance is included.

Trustee Rupp Srch motioned to approve hiring Rich Kastory as a part-time driver for the Senior Transportation System at \$14.00/hr., no benefits included, seconded by Trustee Mussatto. On roll call, Trustees Rupp Srch, Pacilli, Whipple, Mussatto, and Supervisor Valle voted "Aye". Motion passed.

There was no closed session.

Under new business Trustee Rupp Srch reported the Villa Park Fire Department is having a 911 Memorial Service tomorrow morning at 8:30am at the main fire station located at

1400 S. Ardmore right by the high school if anyone is interested in attending, Supervisor Valle offered Happy Birthday wishes to Trustee Mussatto coming up on September 27th.

Under old business Supervisor Valle called to everyone's attention that in their packets is information on Lombard resident Arlene Sujak who celebrated her 93rd birthday with family at the Township, thank you letter from Cpl. Terri Albright from the DuPage County Sheriff's Office regarding her bringing the comfort dog Julia and enjoying meeting staff and all the seniors, ALS Ice Bucket Challenge that the Supervisor took on August 6 and Supervisor Valle also thanked the Trustees and Town Clerk for taking the ALS Ice Bucket Challenge on August 30th at the Township building, and the York Township August 2024 Status Report from Clarke Mosquito. Town Clerk Cuzzone shared an historical tid-bit from a Town Board of Auditors meeting held on April 24, 1961 at the office of the Town Clerk, 30 North Park, Lombard, where 6 Resolutions were passed which included the assessor hiring 3 clerks and hiring 3 deputy assessors, permission to pay all employees semi-monthly, giving the Town Clerk and Supervisor permission to sign a lease for 4 years for Township offices, regarding salary of Supervisor of General Assistance, regarding the Supervisor hiring a social worker, and regarding the bank depository.

There being no further business, Trustee Whipple moved to adjourn the meeting to the Regular Board Meeting to be held on Tuesday, October 8, 2024 commencing at 7:30 p.m., seconded by Trustee Pacilli. Motion passed by unanimous voice vote, whereupon the meeting adjourned.
