**7: President’s Report:** Trinity Services, a company that has been assisting people for over 75 years, is hosting an event on Friday December 5<sup>th</sup>. All proceed benefit people with disabilities and mental illness. President Ledonne would like to express his condolences to Supervisor Murray and his family on the passing of his father. On October 1, 2025 President Ledonne, Supervisor Murray, Carmen Olmetti, and Deb Conroy will be attending a round table discussion on Shaping the Future of Mental Health. All of the Mental Health Boards from around the area will be joining. The CRC has been open for three weeks and have already served 93 clients and have two youths in unit.

**8. Michael Ledonne:** New Business

**9: Presentation: Michael Ledonne 2026 Budget Change Presentation:** Admin Salary and Benefits Allocation adjusted from \$90k down to \$65k. Budget for grants went from 78% to 84.9%. York Township expenses down from \$12,000 to \$0. Reserve Funds adjusted from \$54,000 to \$4,000. Trustee Al Rago suggested taking the \$250k from the CRC grant and adding it the 708 Grant Fund and having the CRC apply for the grant. Michael Ledonne responded that due to the significance of the amount and the fact that it’s an intragovernmental grant, he felt it warranted its own line for transparency purposes. Trustee Rago replied that the board was concerned with the amount being given to the CRC, without proper data showing how many of York Township’s residents it will benefit. President Ledonne responded that it is a one time grant to ensure success of the CRC and he will be attending the next York Township Board Metting to defend the 708 Board’s decision to move forward with this grant to the CRC. He has advised the chair that the money allocated to the CRC must be reserved to benefit the residents of York Township
